

DATA PRIVACY INFORMATION

In order to enable shareholders to attend the Annual General Meeting and exercise their rights within the scope of the Annual General Meeting, voxeljet AG processes personal data (name, title, type of person (natural or legal person) address (consisting of country, city, postcode, street, house number), any differing shipping address, if applicable e-mail address, nationality, number of shares, type of ownership of shares). This is done solely on the basis of applicable data protection laws. The controller is voxeljet AG, Paul-Lenz-Straße 1a, 86316 Friedberg. The legal basis for processing is Article 6 para. 1 sentence 1 c) of the General Data Protection Regulation (GDPR, Datenschutz-Grundverordnung, DSGVO) in conjunction with §§ 121 et seq. German Stock Corporation Act (AktG).

Shareholders are not legally or contractually obliged to provide their personal data; however, the disclosure of their personal data is required for the participation in the Annual General Meeting and the exercise of their rights within the framework of the Annual General Meeting.

Voxeljet AG also deploys external service providers to organize the Annual General Meeting. Voxeljet AG provides them only with the personal data necessary to carry out the services. The service providers process this data exclusively according to the instructions of voxeljet AG. In addition personal data will be made available within the scope of the statutory provisions to shareholders and shareholder representatives in the context of the Annual General Meeting. When shareholders attend the Annual General Meeting, other shareholders of voxeljet AG can view the data recorded on their person in the list of participants. Personal data will not be transferred outside of the European Economic Area (EEA).

Personal data is stored in the context of legal obligations and then deleted.

At any time, affected parties have, under the legal requirements, the right regarding their personal data:

- to request information about the data processed by voxeljet AG as well as a copy of such data (right to information);
- to request rectification of inaccurate data and, taking into account the purposes of the processing, the completion of incomplete data (right to rectification);
- to demand the deletion of the data for legitimate reasons (right to deletion)
- to demand the limitation of the processing of data, provided that the legal requirements are met (right to restriction of processing)
- if the legal requirements are met, to receive the data provided by them in a structured, common and machine-readable format and to transfer these data to another responsible person or, if technically feasible, to have them transferred by voxeljet AG (right to data portability)
- not to be subject to a decision based exclusively on automated processing, unless the legal requirements for this are met. At present, voxeljet AG does not implement automated decision making.

In addition, affected parties have the right at any time to object to the processing of their personal data for reasons arising from their particular situation in the cases provided for by law. If your personal data are processed for the purpose of direct advertising – which is neither happening nor planned at present – you may in any case object to the processing for the purpose of such advertising ("Advertising claims").
